Position Title: <u>Pediatric Nurse Practitioner</u>
Reports To: Family Support Team Coordinator

Job Summary: Communicates and coordinates with physicians and other health care providers regarding child health issues and concerns. Provides family resources coordination, intake assessment, and evaluation services utilizing an interdisciplinary, family-centered and culturally competent approach. Interprets complex medical information pertaining to children referred for services and coordinates care as requested.

Essential Functions:

- 1. Provides home intake assessment/inquiry
 - Screens health status and related records
 - Assesses child and family resources
 - Completes standardized evaluations as requested
- 2. Serves as Primary Consultant for Medically Related Services
 - Consults with staff regarding medical and health issues that have a potential impact on child and family program participation.
 - Reviews immunization records
 - Facilitates/Updates Seizure and Allergy/Asthma Care Plans
 - Provides specialized instruction consultation to families children with special health needs in group and/or home visit contacts as requested
 - Provides medical consultations to children after Individual Family Service Plan (IFSP) is completed at staff request
 - Participates in Medical Home Leadership Network meetings
 - Participates in team meetings for children with vision and/or hearing impairments
 - Coordinates with Family Support Team and attend team meetings
- 3. Provides Family Resources Coordination
 - Informs families of advocacy, support services, funding sources and community resources
 - Provides input for: initial, 6-month, and Annual IFSP in coordination with all team members
- 4. Maintains professional credentials
 - Attends appropriate trainings/seminars to enhance knowledge/skills
 - Continually upgrades knowledge of current research materials
 - Maintains WA registration/licensure as needed
- 5. Other duties as assigned.

Other Functions:

- 1. Employee is dependable and takes initiative in job duties
- 2. Employee communicates effectively with co-workers and consumers
- 3. Employee attends to accuracy and thoroughness of paperwork
- 4. Employee knows the Agency Mission and is Mission oriented

Required/Preferred Work Experience and/or Training:

- Master's Degree in Nursing required with an emphasis in pediatrics preferred.
- Children with special health and developmental needs experience preferred.
- Public Health /Parent Child Health nursing experience preferred
- Ability to obtain and maintain WA State Department of Health License as a Registered Nurse

Required Knowledge, Skills and/or Abilities:

- Knowledge of pediatric health conditions and pediatric drug therapy and immunizations.
- Ability to provide developmental screening, assessment, and evaluation.
- Knowledge of typical and atypical child development processes.
- Knowledge of the Individual Education Plan/Individual Family Service Plan process.
- Knowledge of community resources.
- Awareness of family economic and cultural issues as they relate to early intervention.
- Knowledge of infant mental health and parent-child interaction issues.

- Licensure as Registered Nurse
